flyway connections. Concerns from Williston folks: Big gas tanks are there, still underground (used to be a gas station), sharp curve dangerous. All built on a shell pile. Would never perk; bad place for a bathroom. You can find the breakwater poured by state years ago. Back of Elmer's store was overboard. That burned down. Now just clam house. No property there. Will be a hangout for potheads. Concerned for our neighborhood. Barbara: Historical commemoration for Clam King? Historical info fine but "we don't need no bathroom under it!" (Cecil Tuten) and if you commemorate the Clam King you better include his brother and mention Jarrett Bay Boatworks, etc. as well. "Uncle Charlie run his brand new Buick Century overboard!" James: County owns it and therefore will seek input, probably looking to the DEC to facilitate the discussion about the Clam House. Discussion of who owns property across street.
